

Recap of the County Commissioners Meeting March 2, 2021.

It being the hour of 2:00 p.m., the time set by the Board of Ottawa County Commissioners for the bid opening for Asphalt Concrete Resurfacing of Various Township Roads six bids were received and will be reviewed.
